# FATHER JOHN REDMOND CSPC Minutes of September CSPC Meeting and AGM September 26, 2017

**Welcome**, **Introductions Opening Prayer**: Co Chair Gary Signarowski called the meeting to order at 7 pm. An Opening Prayer was then led by him.

**Agenda Review.** Gary reviewed the agenda with the meeting and it was determined that there was no further business to add to the agenda. The agenda was accepted.

#### 1. Overview of CSPC

Gary Signarowski showed a slide presentation of CSPC (what it is, its purpose, structure and roles, frequency of meetings, ongoing activities and what's new for 2017-18). He advised the meeting that any parents wishing to become voting members should be prepared to attend all meetings and to be willing to volunteer at appropriate school events.

### 2. Annual Report by Co - Chair.

Gary provided a detailed breakdown of CSPC for the 2016-17 school year. He talked about all the school initiatives, the various teacher requests, events where CSPC members had volunteered their time, various fundraising programs, some advocacy matters and pro-grants that were applied for.

#### 3. Financial Statement for 2016-2017: Co Chair:

Tony Pantusa, the Co Treasurer, reviewed the financial statements as part of the meeting. The statements show an opening balance of \$13,424.67 on September 1, 2016. Total deposits for the year were \$36,851.79 as a result of various fundraising activities such as flower/poinsettia sales, Kaleidoscope, cookie dough sales, concession sales, tea sales, used uniform sales and a school activity fee of \$10,580. The closing bank balance as of August 31, 2017 was \$17,707.29. After accounting for outstanding cheques totaling \$448.81 and for pending expenditures earmarked for RAP, the potential balance is \$11,119.39 (not including 2017/18 activity fee).

After discussion on motion made by Sandra Currie and seconded by Gary Signarowski, the financial statements were approved.

<u>Theatre Arts Campaign re-branding</u> - —From "Seat Sale" to TBD — Gary advised that the Theatre Arts Room was in need of upgrades. This will need to be discussed at future CSPC meetings.

<u>Canada 150 Grant</u> – Gary advised the meeting that FJR was awarded a grant of almost \$50,000. "Our Home on Native Lands" application set out some ideas that FJR proposed to use the money for such as: planting a Three Sisters Garden (corn, beans, and squash), displaying Student Art Work, and building an Outdoor Performance Space. CSPC would be contacted by planning committee to let us know what we could help with.

#### Traffic Issues

Gary explained the traffic problems in front of Father John Redmond School and said that the problem would only get worse once the elementary school opens next year. He has been in talks with, the Trustee, Ms. Andrachuk, to see if there is a solution to alleviate the congestion.

#### \$1,000 Pro Grant - 2016-17 Application

#### **TCDSB Pastoral Plan**

If the grant is authorized, we will need to arrange for a Speaker to come in the talk about nutrition, healthy eating and family dinners and to demonstrate culinary arts (tips and techniques to save time in food preparation).

### **Fundraising**

Fundraising initiatives would be discussed further at our next meeting. Gary suggested that we should stick to the fundraisers that bring in the most amount of money, with the least amount of work such as the Used Uniform Sale and Kaleidoscope. This could be discussed in more detail at our next meeting.
